

### DESCRIPTION

ISHA

The TSOP39...TR1 series are miniaturized receiver modules for infrared remote control systems. Two PIN diodes and a preamplifier are assembled on a leadframe, the epoxy package contains an IR filter. The demodulated output signal can be directly connected to digital circuitry for decoding.

The TSOP393..TR1 series devices are optimized to suppress almost all spurious pulses from energy saving lamps like CFLs. These AGC3 devices may also suppress some data signals if continuously transmitted.

The TSOP395..TR1 series contains a very robust AGC5. This series should only be used for critically noisy environments.

These components have not been qualified according to automotive specifications.







Fig. 2 - Pulse Length and Sensitivity in Dark Ambient






Fig. 4 - Output Pulse Diagram




Fig. 5 - Frequency Dependence of Responsivity




Fig. 6 - Sensitivity in Bright Ambient




Fig. 7 - Sensitivity vs. Supply Voltage Disturbances




Fig. 8 - Max. Envelope Duty Cycle vs. Burst Length




Fig. 9 - Sensitivity vs. Ambient Temperature




Fig. 10 - Relative Spectral Sensitivity vs. Wavelength




Fig. 11 - Horizontal Directivity




Fig. 12 - Vertical Directivity




Fig. 13 - Sensitivity vs. Supply Voltage



## Vishay Semiconductors

### SUITABLE DATA FORMAT

This series is designed to suppress spurious output pulses due to noise or disturbance signals. The devices can distinguish data signals from noise due to differences in frequency, burst length, and envelope duty cycle. The data signal should be close to the device's band-pass center frequency (e.g. 38 kHz) and fulfill the conditions in the table below

When a data signal is applied to the product in the presence of a disturbance, the sensitivity of the receiver is automatically reduced by the AGC to insure that no spurious pulses are present at the receiver's output.

Some examples which are suppressed are:

- DC light (e.g. from tungsten bulbs sunlight)
- Continuous signals at any frequency




Fig. 14 - IR Disturbance from Fluorescent Lamp With Low Modulation




Fig. 15 - IR Disturbance from Fluorescent Lamp With High Modulation

- Strongly or weakly modulated pattern from fluorescent lamps with electronic ballasts (see Fig. 14 or Fig. 15)




### **PACKAGE DIMENSIONS** in millimeters





### TAPING VERSION TSOP..TR1 DIMENSIONS in millimeters










### LEADER AND TRAILER DIMENSIONS in millimeters







### **DRY PACKING**

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



### **FINAL PACKING**

The sealed reel is packed into a cardboard box.

### **RECOMMENDED METHOD OF STORAGE**

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity  $\leq$  60 % RH max.

After more than 72 h under these conditions moisture content will be too high for reflow soldering.

In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 h at 40 °C + 5 °C / - 0 °C and < 5 % RH (dry air / nitrogen) or

96 h at 60  $^\circ\text{C}$  + 5  $^\circ\text{C}$  and < 5 % RH for all device containers or

24 h at 125 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC<sup>®</sup> standard J-STD-020 level 4 label is included on all dry bags.
